With regards to Report 320-2025 (Animal Services Update), I want to speak to the ongoing issues and what the community continues to experience.

While the City has taken steps to resumes responses to stray dogs at large and reunite pets on-line, these actions are interim measures and not equivalent to a fully operational municipal shelter that meets community expectations.

Provide specific actions you would like Council to take:

That City Council direct administration to move forward with the Reinstatement of Animal Services

Specifically, I am asking that Council:

Reject any recommendation that excludes reopening; ensuring the facility is reopened as a city-run service.

Direct administration to develop and implement a plan to reopen and properly operate the facility, including an adoption centre (open to the public), vet care, and sheltering of stray and abandoned dogs and cats.

This action will reflect the strong public support demonstrated by the 5,132 signature petition and ensure the community's need for a municipal Animal Services is met efficiently and responsibly.
