Dear FCM members,

Housing Infrastructure and Communities Canada has released a **consultation paper** seeking input into the creation of Build Canada Homes (BCH), the federal government's new entity that will be tasked with building 500,000 homes per year. Learn more about it **here**.

FCM's submission will be focused on:

- **Speed**, **predictability & scale** BCH should build on proven models, such as the Rapid Housing Initiative or a streamlined portfolio-based approach.
- **Continuity & stability** Establishing BCH will take time, and we cannot lose momentum to address affordable housing. Affordable housing projects that are already in the application pipeline should be prioritized for funding through BCH.
- Alignment with housing-enabling infrastructure funding Infrastructure funding needs to be aligned to ensure that the 500,000 housing units per year are serviced.
- **Building capacity to deliver** Smaller communities may need upfront support for feasibility studies, meeting program requirements and more.
- Providing funding for repairs/conversions BCH should include funding for conversions and repairs.
- Regional benefits and reach BCH should ensure that affordable housing is built in all regions of Canada – rural, northern, mid-size and urban communities and include smaller developers and prefabricated housing manufacturers. This will ensure that the economic and social benefits of BCH are shared across the country.

RE: Housing Accelerator Fund Action Plan Update – September 2025

The purpose of this memorandum is to provide an update on the progress made towards achieving the Housing Accelerator Fund (HAF) targets and Action Plan milestones.

Housing Target: Progress Update

Thunder Bay's housing supply growth target from March 1, 2025, to February 28, 2026, is 708 net permitted units.

Table 1. Net permitted units since March 1, 2025, by target type, as of September 8, 2025.

Housing Target: Permit Projections

To estimate the number of permits that may be issued by the end of the second HAF reporting period, a scan of building permit applications in "Intake Review" or "Under Review" was completed. As of September 8, 2025, 25 building permit applications are current in Intake Review or are Under Review. **Should these applications be issued permits it will result in an additional 134 units, for a total of 324 units.** This does not capture permits that will be submitted from September 9, 2025, to February 2026.

In addition, 30 projects (451 units) provisionally approved for funding through the City's HAF supported grants have not applied for a building permit. If these projects proceed before February 2026, it will result in a total of 775 units, exceeding the target for reporting period 2. However, there are several projects that will likely be cancelled and not proceed.

Therefore, we can anticipate the number to fall between 324 and 775 units, with a conservative estimate of 350 - 400 permitted units and optimistic estimate of 450 - 500 permitted units.

Grant Intake 1 Update

As of September 8, 2025, of the 66 projects awarded funding 10 projects are complete, 36 projects have an issued building permit, 3 projects have applied for a permit and are awaiting issuance, 13 projects have been cancelled, and 4 projects have not demonstrated significant progress and are at risk of cancellation. Of the 6 projects awarded funding through the Affordable Rental Housing Funding Program, one has been issued a building permit.

Grant Intake 2 Update

As of September 8, 2025, of the 36 projects awarded funding 1 project has been issued a building permit, 12 projects have applied for a permit and are awaiting issuance, 19 projects have not yet applied for a permit, 2 projects have been cancelled, and 2 projects are being monitored for cancellation.

Initiative 6: Secondary Planning & Infrastructure Planning in Support of Housing Strategy, Milestone 1: Conduct Infrastructure Planning (Jan 01, 2024 – Dec 31, 2025).

 - Review of the Property Standards By-law and Vacant Building Security By-law and gap analysis of comparator municipalities was completed. Data collection to determine number of vacant buildings is underway.
