10. Encampment Response & Temporary Shelter Village Update

Director - Engineering Matthew Miedema and Drug Strategy Specialist & Encampment Response Lead Rilee Williamen provided an update on the Encampment Response Plan and Site Safety Assessment for the Temporary Shelter Village.

At the April 28, 2025 Committee of the Whole meeting Report 143-2025–Growth–Strategy & Engagement – Report Back – Temporary Village Initiative – Site Location Comparison was presented and a resolution to approve Kam River Heritage Park as the site for the Temporary Shelter Village Initiative was passed and then ratified at the May 5, 2025 City Council meeting.

A safety assessment was completed at the Kam River Heritage proposed site for the Temporary Shelter Village, review & feedback showed the site has serious safety risks being in the presence of the river and railcars, an increase to the budget, a surrounding fence and increased monitoring would be required making the location impractical.

At the June 23, 2025 City Council meeting a resolution to rescind the decision ratified by Council on May 5, 2025 was passed.

At the June 23, 2025 City Council meeting a resolution was passed recommending that Administration review alternate locations for the Temporary Village that may include locations previously reviewed by City Council.

The updated report will be presented at the July 14, 2025 council meeting; funding is contingent on the number of units being erected, July 30th is the deadline for funding and construction is required to start in July and end December 31, 2025 to remain eligible for funding.

- adoption of the Enhanced Encampment Response Plan in 2024, recognizing the human rights of people experiencing homelessness and prohibited forced evictions unless viable alternatives exist
- site selection
- health & safety risks
- risk of increase in encampments
