THE CORPORATION OF THE CITY OF THUNDER BAY
BY-LAW NUMBER 64-2023

A By-law to repeal By-law 25/2017 being a By-law to appoint a City Treasurer for The Corporation of the City of Thunder Bay.

Recitals

1. Section 286(1) of the *Municipal Act, 2001*, provides that City Council shall appoint a City Treasurer for handling the financial affairs of the Municipality directed by the Council of the Corporation.
2. Section 286(2) of the *Municipal Act, 2001* states that municipalities may appoint deputy treasurers who shall have all the powers and duties of the treasurer under this and any other Act.
3. The Corporation of the City of Thunder Bay provides for the General Manager Corporate Services and Long-Term Care to hold the position of City Treasurer.
4. On March 6, 2017, City Council appointed Linda Evans as the City Treasurer by By-law 25/2017.
5. On August 24, 2020, City Council appointed Emma Westover as Deputy City Treasurer by By-law 81/2020.
6. On February 28, 2023, Linda Evans will be retiring from the Corporation.
7. It is deemed necessary to repeal By-law 25/2017 appointing Linda Evans as the General Manager – Corporate Services and Long-Term Care and City Treasurer of The Corporation of the City of Thunder Bay.

ACCORDINGLY, THE COUNCIL OF THE CORPORATION OF THE CITY OF THUNDER BAY ENACTS AS FOLLOWS:

1. By-law 25/2017 appointing Linda Evans as City Treasurer of The Corporation of the City of Thunder Bay is repealed effective February 28, 2023, at 11:59 p.m.
2. This By-law shall come into force and take effect on the date it is passed.
