# EXECUTIVE SUMMARY

This report provides a summary of the public open house event that took place on May 3, 2023 at Victoriaville Centre. The Reimagine Victoriaville project is an exciting opportunity for the City of Thunder Bay to initiate revitalization in the area with the removal of Victoriaville Centre and the development of new streets and public spaces. The public open house offered an opportunity for the public to learn about the project, the process to remove Victoriaville Centre, the results of Public Open House #1, the refined design for the new street and public spaces, and the architectural design of the Civic Centre, Court Services, and McKellar Hub. Public feedback was gathered regarding the concept designs for the future of Victoria and Syndicate Avenues, and the surrounding public buildings.

## **Phase 2 Timeline**



The public, stakeholder, and rightsholder engagement process for Phase 2 consisted of the following:

- Participant meetings with targeted rightsholder and stakeholder groups in July 2022 to gather initial needs and concerns.
- Two public open house events in August 2022 to re-launch the project with the public-at-large and gather input on desired activities and two concept design themes.

## **Executive Summary Cont'd**

- Additional participant meetings in Winter 2023 with key stakeholders and Indigenous Nations, organizations, and groups to present updated concept design ideas for feedback.
- A final public open house event in May 2023 to present the preferred design concept and architectural concepts.

A robust advertising campaign was developed to promote public open house #2, including promotion on the City website, City social media, newspaper advertisement in the Chronical Journal, posters, a postcard maildrop to 7500 nearby residents and businesses, and an email invitation to targeted stakeholders, rightsholders, and past open house participants.

The open house event took place in the centre court of Victoriaville Centre on Wednesday, May 3, 2023 from 3:00 - 7:00pm. This event targeted nearby residents and business owners with approximately 140 people attending, and 68 comment forms completed at the in-person event. This event brought in nearby business and property owners, people who work nearby, and local residents. Overall, the event was well received by the participants and many were excited to visualize the building upgrades and new outdoor spaces.

The event featured a display of 12 presentation boards with members of the KGS Group (KGS), Scatliff + Miller + Murray (SMM), and i4architecture (i4a) consultant team stationed to present information, and answer questions. Presentation boards provided information about:

- Project overview, why we are here today, and how to participate
- Project process and timeline
- What we heard at previous participant meetings and Open House #1 (August 2022)
- Preferred design alternatives for street design, public space, and building renovations represented in plans, renderings, and text
- Next steps

To provide more opportunities to learn and engage with the project, the project website on <u>thunderbay.ca/getinvolved</u> was updated on May 11, 2023 with an online component of the public open house. This included an online survey that was live until May 25, 2023. One person completed the online version of the survey. In total, including the in-person and online events, 69 survey/comment form responses were received.

Through the comment forms and online survey, we learned about the public's feedback on the street design for Victoria Avenue, the public spaces for Syndicate Avenue, and the building entrance and façade improvements. Overall, participants were very receptive to the project, and comments were generally positive.

## **Executive Summary Cont'd**

Respondents expressed support for the following design elements:

- Open flow of vehicular and bike traffic on Victoria Avenue, with tabled pedestrian crossing to give pedestrians being priority;
- Inclusion of wide sidewalks and space for patios on the sidewalk;
- Open, inviting, and welcoming design of the plaza and gardens;
- Green space and trees in the plaza and the shade provided by the tree canopy; and
- Modern, fresh, and clean aesthetic of the buildings entrances designs that fit in with the aesthetic of the current buildings.

Respondents believe this will be a great space for families to gather, for events and festivals, and for pop-up performances. They indicated that they are most excited about attending markets and cultural events in this space in the future, and sit and enjoy patio space of nearby businesses.

Overall, the participants were very receptive to the project, and comments were generally positive. There was some concern expressed for cleanliness and maintenance of the public spaces and ongoing concerns about safety in and around the area, to ensure it becomes a place of pride for downtown Fort William. Some nearby business owners expressed a need for additional street parking to create better access to their place of business and service. There was also interested to include a sheltered or covered area to protect visitors from the elements.

## **2** PUBLIC OPEN HOUSE #2 EVENT RESULTS

## 2.1 Open House Participation

Approximately 140 people attended the open house on Wednesday, May 3<sup>rd</sup>, 2023 from 3:00 – 7:00 pm at centre court of Victoriaville Centre. 122 participants signed in and 93 participants shared their contact information with the project team to receive future project communications. Participants took their time to read and view the presentation boards to learn about the project and review the refined design. 68 comment forms were completed at the event.

On May 11, 2023, the project website on <u>thunderbay.ca/getinvolved</u> was updated with an online component of the public open house including the presentation boards and online survey that closed on Thursday, May 25, 2023. Between April 26 and May 25, 2023, 494 people visited the project website, and 146 people downloaded documents from the website to review. One person completed the online survey.

The following is a summary of participant responses and feedback. All raw data can be found in Appendix A.

What do you like best about the proposed street design for Victoria Avenue?

- Most respondents support the opening of Victoria Avenue to **all modes of transportation** and feel the design allows for an **ease of flow**.
- Many respondents support the **strong pedestrian connection** and focus, and believe the raised intersection is a positive contribution. Some even wanted to see the design be more pedestrian and bike friendly.
- Many respondents also believe this will **allow for good flow of vehicular traffic** through the area.
- Many respondents identified they liked the **wide sidewalks** and wanted to see room for **patio space along Victoria Avenue** for future and current businesses.
- **Concerns about crime** in the area were expressed by some respondents.
- There were a couple of respondents who were disappointed by the design, identifying there was **too much emphasis on tree planting.**
- Several respondents noted that the design **improved the aesthetics of the area**, including the public space and architectural designs.
- One respondent noted that the design needs to be **more accessible** as the population demographics of Fort William trend older than the average age in Thunder Bay.
- Several respondents noted they would like to see **more street parking** on Victoria Avenue to serve the nearby businesses.

What do you like best about the proposed public spaces (plaza and gardens)?

- Many respondents noted they appreciated the **open, welcoming, and inviting design** of the proposed public spaces.
- Some respondents liked the **inclusion of greenspace** in downtown public spaces, which can also work well for events.
- Respondents were eager to see future events, activities, pop-ups, and festivals in these public spaces.
- Many respondents noted they liked the inclusion of trees and garden spaces, creating a shady tree canopy and comfortable place to sit.
   Some did note they would like to see even more trees and natural components in the public space.
- One respondent noted they would like to see a **fountain or public artwork** included in the project.
- Some participants noted they would like to see lots of **open seating options**.
- Some respondents commented on the **ongoing need for operations and maintenance** to ensure this space stays **clean and well cared for.**
- One concerned respondent did not think previous concerns were addressed and thought the **design focused too much on beautifying the space.**
- A few respondents noted this looks like **a great gathering space** for families and others.

What do you like best about the proposed building entrance and façade improvements?

- Overwhelming, respondents had **positive feedback** about the building entrance and facade improvements, noting the design looks **attractive and modern**.
- Some noted that the designs are **well integrated with adjacent structures.**
- Respondents commented that the architectural designs are **public** friendly, hospitable, and community conscious.
- Some noted that the architectural designs **pay tribute to the history of the area.**
- Respondents noted they liked the **functional and attractive material selection,** including the use of wood, creating **a warm and welcoming environment.** However, two respondents disagreed and noted it was **too industrial looking.**
- Some respondents commented that the building improvements will be **attractive to new businesses downtown.**
- One respondent noted they liked the **lighting and wayfinding improvements** with the building renovations.
- One respondent noted that they believed the building improvements should be **more welcoming and accessible.**

## **Comment Form Question 8**

If public art were included in this project, who do you think should be engaged to discuss potential opportunities or themes?

- Many respondents commented that the City should consult with Indigenous people, including Indigenous artists, Métis, First Nation Elders and youth, and Fort William First Nation.
- Specifically, one respondent noted that the Ahnisnabae Art Gallery • should be engaged as part of the public art program.
- Many respondents noted that **local artists** should be included in the • discussion about public art, including local musicians, visual artists, writers, and poets.
- Other respondents noted that local business owners and the Fort William BIA should be engaged regarding public art.
- One respondent noted that **up-and-coming artists from the local** • colleges and universities should be a part of the discussion.

Please provide any additional comments or considerations for this project.

- Consider access to electricity for outdoor events and activities.
- It is important to **invest in the design** for this future space, and include elements from the original plans, such as the **water feature**, **stage**, **and gardens**.
- Consider **covered or sheltered areas** to protect people from the elements and weather.
- Concerns about the ongoing **cleanliness** of the new development and downtown area, in particular, consider **public washrooms, safe needle drops, and many garbage cans.**
- Extend the revitalization and redevelopment of Victoria Avenue beyond Victoriaville Centre with **new sidewalks and tree plantings** all the way to Simpson Street.
- Include healing Indigenous plants.
- Concerns about safety in the area and want to see greater support of the BIA as well as supports for the homeless population. Some also noted that the nearby parkade is considered a dangerous place by many.
- **Concerns about illegal activities** happening in the area and the effect on safety.
- Consider **on-street parking on north side of Victoria Avenue** for access to businesses on north side of the street.
- Consider a future location for the Thunder Bay Walk of Fame.

Lastly, we asked survey respondents to share with us their experience of the public open house event. The majority of respondents (69%) indicated that they had an opportunity to talk to and ask questions of the project team. Most respondents (75%) also indicated that they understood the project process. Both are signs that the event was an effective communication tool and help gain more project understanding from the general public. It is also noted that most participants arrived between 3:00 - 4:00 pm and centre court was filled with many interested participants, and not all may have had a chance to talk to the project team.

- Overall, most respondents were pleased with the open house event, thought it was well thought out, organized, and were grateful to have the opportunity to share their feedback and input.
- Respondents expressed an eagerness to see construction begin, view this project as high priority, and want to see the downtown transformed.
- One respondent felt their concerns expressed at public open house #1 were not addressed in the refined design and another respondent was disappointed by the project.
- One respondent requested more information about how safety and security will be addressed in the future.
