12. Downtown Fort William Revitalization Committee Update

The Strategic Renewal Plan that was presented to Council July 17, 2023, is now endorsed and the plan is with Administration.

A discussion was held relative to who owns the Strategic Renewal Plan moving forward: A new Economic Development Group or the existing Community Economic Development Commission? The plan will require attention and investments.

Interior revitalization will start this year and the demolition of the exterior will start in 2024.

KGS held an open house in Victoriaville in May regarding the demolition and received positive comments from the public regarding the reopening of Victoria Avenue.

Councillor Rajni Agarwal expressed concern regarding budget cuts and decreased frequency with the spring clean ups. The Committee stated that this is a City issue not a Committee issue.

A suggestion was made to submit a resolution to Council around the Clean, Green and Beautiful Committee's mandate regarding clean-ups.

Councillor Rajni Agarwal will provide a presentation regarding the city of North Bay's clean-up program that runs April to October with 700 volunteers. Businesses sponsor the program to fund supplies. A concern was raised as to who would over see a multi-faceted extended clean-up program.
