# 7.1 Community Economic Development Commission - Pool 6 Highest & Best Use Study

Pool 6 Highest & Best Use Study - Purpose, Goals & Objectives

- Project supports the Waterfront Master Plan update.
  - Evaluate multiple development possibilities to determine maximum economic value.
  - Support City of Thunder Bay.
    - Examine development options which are legally permissible, physically possible, and financially feasible.
      - Zoning.
      - Building restrictions.
      - Space available.
    - Determine what is a good fit for the area and compliment to services available in the area.
      - factoring in the surrounding community
- Consultants were acquired through a formal RFP process.
