By-law Description: A By-law to close a portion of the street known as Georgina Avenue Street as shown on Reference Plan 55R-15249.

Authorization: Report No. 2024CLS.002 (Realty Services) - Committee of the Whole - February 12, 2024.

By-law Explanation: The purpose of this By-law is to close a portion of the untravelled road allowance known as Georgina Avenue at Gore Street West (north side) and described as Part of Georgina Avenue, Registered Plan W219, being Part 1 on Reference Plan 55R-15249.

BY-LAW NUMBER 160-2024

A By-law to close a portion of the highway known as Georgina Avenue, as shown on Registered Plan W219, in the City of Thunder Bay, in the District of Thunder Bay

Recitals

1. It is desirable to close the highway referred to in Section 1 of this By-law.
2. Notice to the public of Council's intention to pass a by-law closing the highway referred to in Section 1 of this By-law has been given as required by the Corporations Notice By-law.
3. Council provided opportunity to any person wishing to make submissions with respect to the closing of the highway referred to in Section 1 of this By-law.
4. The lands that form the highway are not required for highway or other municipal purposes.

ACCORDINGLY, THE COUNCIL OF THE CORPORATION OF THE CITY OF THUNDER BAY ENACTS AS FOLLOWS:

1. The highway described in this Section of this By-law, according to a Plan registered in the Land Registry Office for Thunder Bay more particularly described as follows:

Portion of Georgina Avenue at Gore Street West (north side), Registered Plan W219, being Part 1 on Reference Plan 55R-15249, in the City of Thunder Bay, in the District of Thunder Bay

Is closed as a highway of the Corporation.

2. This By-law shall come into force and take effect upon the date it is passed, when a certified copy is registered in the land Registry Office, at Thunder Bay, Ontario, pursuant to Subsection 34 (1) of the *Municipal Act*, 2001, as amended.
