THE CORPORATION OF THE CITY OF THUNDER BAY  
BY-LAW NUMBER 114-2025

A by-law to amend By-law 087-2007, being a by-law to prohibit heavy traffic on certain highways within the City of Thunder Bay with respect to Schedule "D" restrictions over 5,000 kg limit.

Recitals

1. It is deemed necessary and expedient to amend By-law Number 087-2007 being a by-law to prohibit heavy traffic on certain highways within the City of Thunder Bay, with respect to Schedule "D" (Restrictions over 5,000 kg) by resolution of Committee of the Whole dated May 5, 2025.

ACCORDINGLY, THE COUNCIL OF THE CORPORATION OF THE CITY OF THUNDER BAY ENACTS AS FOLLOWS:

1. THAT Schedule "D" – 5,000 Kilogram Limit, is hereby amended by inserting therein, in columns herein set forth, in alphabetical order, the following Weight Restriction location:

2. This By-law shall come into force and take effect on the date it is passed.
